
RESOLUTION NUMBER R-275401

ADOPTED ON APR 02 1990

BE IT RESOLVED, by the Council of The City of San Diego, that the acceptance by the City Manager of easement deeds of LOMA VISTA CENTER PARTNERS, a California limited partnership, executed in favor of The City of San Diego, bearing date of August 21, 1989, copies of which deeds are on file in the office of the City Clerk as Document Nos. RR-275401-1 and RR-275401-2, granting to said City easements for public street purposes and sewer purposes in Lots 1, 2, 3 and 4, Peterson Subdivision, Map 5442, and in Lots 10 and 11, Wiemeyer Tract, Map 2291, as more particularly described in said deeds, be, and the same is hereby approved; and the land therein conveyed for public street purposes is hereby dedicated as and for public streets, and the same are hereby named 47TH STREET and MARKET STREET.

BE IT FURTHER RESOLVED, that the City Clerk shall cause the deeds and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder at no fee for the benefit of the City, with no documentary tax due.
