
BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a First Amendment to the agreement with Estrada Land Planning for professional services in connection with completion of the Balboa Park Master Plan, under the terms and conditions set forth in the First Amendment on file in the office of the City Clerk as Document No. RR-275413, together with any reasonably necessary modifications or amendments thereto which do not increase project scope or cost which the City Manager shall deem necessary from time to time to carry out the purposes and intent of this amendment.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$20,798.51 from CIP No. 21-834.0, Balboa Park Requirements, Transient Occupancy Tax Unappropriated Reserve Fund No. 102242, is hereby authorized, solely and exclusively for the purpose of providing funds for the above amendment.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is authorized to transfer excess budgeted funds, if any, to the appropriate reserves upon advice of the administering department.
