BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for METRO PUMPING STATION NO. 2 - 7TH PUMP INSTALLATION.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$912,224 within the Sewer Revenue Fund 41506 from CIP No. 46-111.0 ROSE CANYON TRUNK SEWER to CIP No. 46-101, METRO PUMP STATION NO. 2, ADDITIONAL PUMPS.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$912,224 from Sewer Revenue Fund, CIP No. 46-101, METRO PUMP STATION NO. 2 ADDITIONAL PUMPS, is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to retain excess budgeted funds, if any, in the appropriate reserves.
