SUBJECT:

Woodfin Suites. PLANNED COMMERCIAL DEVELOPMENT PERMIT (No. 88-0739), COMMUNITY PLAN AMENDMENT, AMENDMENT TO PLANNED INDUSTRIAL DEVELOPMENT PERMIT (No. 88-0133), and REZONE for the construction of a 123-suite hotel on 3.6 acres. The hotel would be three stories, and would include two small meeting rooms, a dining room, and an outdoor swimming and recreation area. The project site is located on the north side of Mira Mesa Boulevard, between Lusk and Pacific Heights Boulevard. (Lot 2, Pacific Corporate Center, Unit No. 7, Map No. 11986). Applicant: Lincoln Property Company.

CONCLUSIONS:

The project would have a significant interior noise impact from aircraft overflights from NAS Miramar. The exterior maximum noise level that would affect the proposed hotel would be 87 dBA. In aircraft noise environments above 60 dBA CNEL, a hotel requires attenuation of interior noise to a CNEL of 45 dBA. Mitigation measures would be provided in the form of sound attenuation through structural methods to reduce interior noise levels to the required levels. The noise level reduction would be assured through review of the building plans by the City's Noise Abatement and Control Officer, as required by a condition of the Planned Commercial Development (PCD) permit. This condition would reduce noise impacts to below a level of significance.

MITIGATION MEASURES INCORPORATED INTO THE PROJECT:

As a condition of the PCD, building plans for the hotel would be reviewed by the City's Noise Abatement and Control Officer to assure that the interior CNEL in the hotel rooms would not exceed 45 dBA.
