WHEREAS, the Landscape Technical Manual Committee was formed to assist City staff in the review of the consultant's recommendations; and

WHEREAS, the Landscape Technical Manual Committee willingly and voluntarily donated time and effort towards the completion of the Landscape Technical Manual, which time might otherwise have been devoted to professional and business pursuits; and

WHEREAS, the "City of San Diego Landscape Technical Manual" was adopted on October 15, 1989; and

WHEREAS, it is fitting and appropriate for the citizens of San Diego to recognize the invaluable contributions of the Landscape Technical Manual Committee; NOW, THEREFORE,


