



BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$20,000 from Community Development Block Grant Fund 18523/5633/3301, BARRIO YOUTH CENTER, from CIP No. 37-195, is hereby authorized solely and exclusively for said project and related costs and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
