BE IT RESOLVED, by the Council of The City of San Diego that the low bid of BLUE SKIES LANDSCAPE MAINT., meeting specifications, is hereby accepted and the City Manager is hereby authorized to execute a contract for furnishing COMPLETE LANDSCAPE MAINTENANCE OF TEN (10) SELECTED SITES (COMMUNITY PARK & RECREATION DIVISION, PARK AND RECREATION DEPARTMENT) as may be required for a period of one (1) year beginning May 1, 1990 through April 30, 1991, per prices on file in Purchasing Department, for a total cost of \$199,989.12; terms 1% 20 days; with options to renew for four (4) additional one (1) year periods, with price escalations not to exceed 10% of prices in effect at the end of each prior year.

BE IT FURTHER RESOLVED, that in the event the contractor is unable to perform in accordance with specifications, the Purchasing Agent is authorized to terminate the contract and award to the next low bidder(s) or to solicit and award emergency bids until the contract can be formally rebid.
