BE IT RESOLVED, by the Council of the City of San Diego that the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for CONSTRUCTION OF WATER AND SEWER MAIN REPLACEMENT GROUP 465, San Diego, California, filed in the office of the City Clerk of the City of San Diego, California, on APR 16 1990, and bearing official Document No.

W.D. 170211/180161, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CONSTRUCTION OF WATER AND SEWER MAIN REPLACEMENT GROUP 465.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$1,398,314 from the Sewer Revenue Fund No. 41506, CIP No. 46-111.0 ROSE CANYON TRUNK SEWER, to the Sewer Revenue Fund No. 41506 Sewer Construction Outlay (70492), CIP No. 44-001, ANNUAL ALLOCATION - SEWER MAIN REPLACEMENTS.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$1,398,314 from Sewer Revenue Fund No. 41506 Sewer Construction Outlay (70492), CIP No. 44-001, and \$1,024,039 from Water Revenue Fund 41502 Water Construction Outlay (70592), CIP No. 73-083, is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
