

BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for OCEAN BEACH RECREATION CENTER MULTI-PURPOSE COURTS.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$37,500 from Ocean Beach Community Park (Proposition 70) Fund No. 38009, CIP No. 29-694.0 OCEAN BEACH RECREATION CENTER - MULTI-PURPOSE COURTS is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
