
ADOPTED ON APR 16 1990

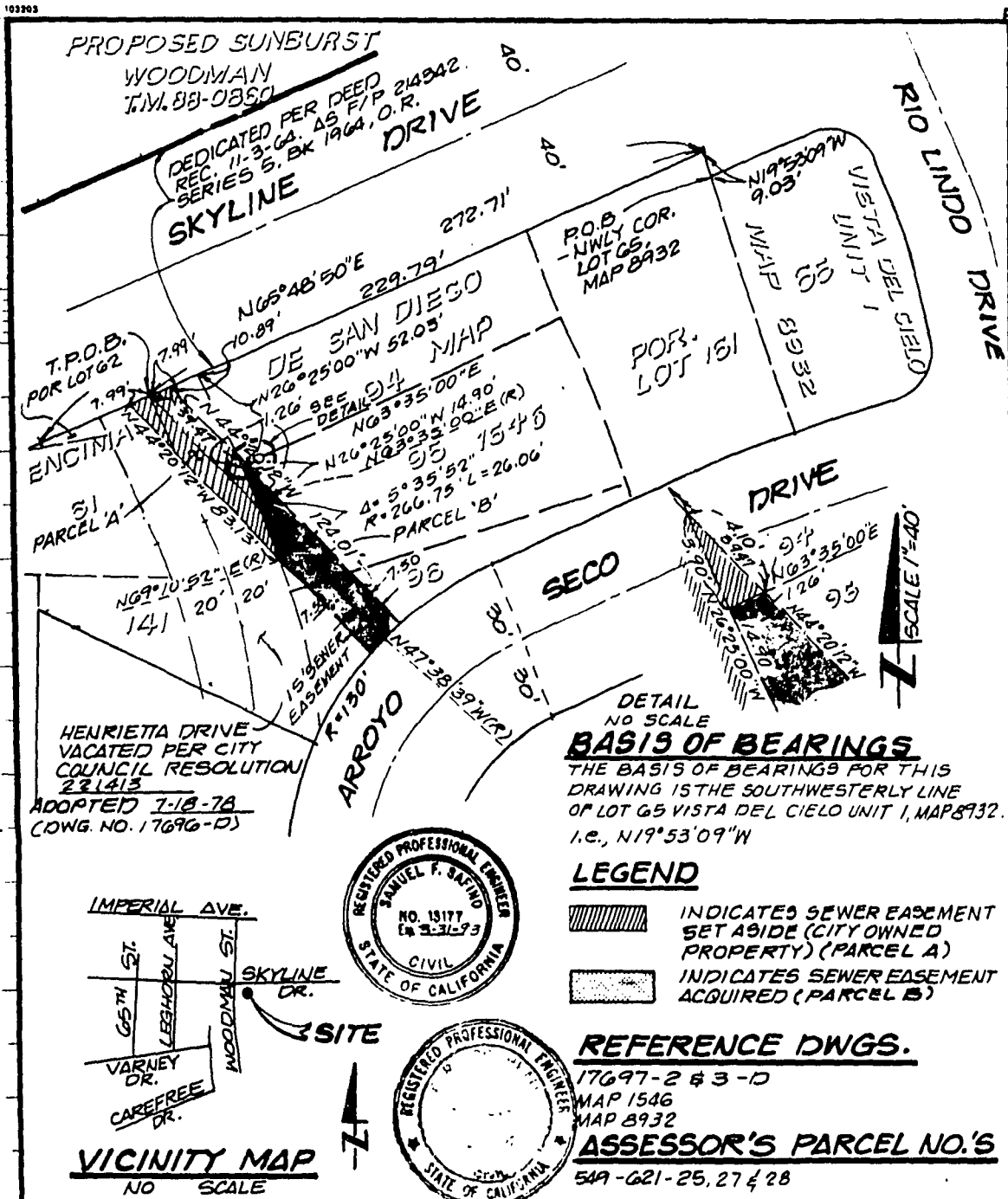
