WHEREAS, the Special Projects Pilot Program FY 90 was designed by the San Diego Commission for Arts and Culture (Commission) to provide funding for programs which foster the stabilization and diversification of San Diego's cultural base, enhance the quality of life in the City's neighborhoods, and pursue the vision of San Diego as a cultural destination; and

WHEREAS, the FY 90 Special Projects Pilot Program was approved by the City Council on July 18, 1989, with an allocation of \$46,450.00 in Transient Occupancy Tax (TOT) Special Promotional Program funding; and

WHEREAS, in 1989, the City was granted \$37,717.00 from the California Arts Council State/Local Partnership Program (SLPP), which was designated for projects benefiting multi-cultural organizations, artists and communities; and

WHEREAS, additionally, on November 13, 1989, the Combined Arts and Organization Council of San Diego County (COMBO) notified the City Manager's office that \$7,542.59 remained unencumbered as part of a FY 88 COMBO Transient Occupancy Tax Beneficiary Grant program; and

WHEREAS, COMBO was required to return the City's portion of these unused funds to The City of San Diego by January 1, 1990, in the amount of \$5,657.00; and

WHEREAS, the City Manager recommends that the refunded amount be used to augment the Special Projects Pilot Program fund; and

WHEREAS, through direct mail, print and broadcast media, non-profit organizations were notified that the Special Projects Pilot Program applications would be available December 27, 1990; and

WHEREAS, the deadline for submission was February 5, 1990; and

WHEREAS, the Special Projects Pilot Program Review Panel consisted of four (4) members of the Commission and two (2) representatives from the community; and

WHEREAS, the Panel reviewed fifty (50) applications on February 16-17, 1990, and brought their recommendations to the full Commission on February 23, 1990; and

WHEREAS, the final recommendation of the Commission is to fund twenty-seven (27) organizations for the Special Projects Pilot Program, as follows:

BE IT FURTHER RESOLVED, that the City Council hereby accepts unused TOT funds returned from COMBO in the amount of \$5,657.00 and that those funds be earmarked to augment the Special Projects Pilot Program.

BE IT FURTHER RESOLVED, that the City Manager be authorized to secure and execute contracts with the twenty-seven (27) above-named organizations in amounts not to exceed those recommended by the City Manager, as shown above.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be authorized to expend an amount not to exceed: 1) \$46,450.00 from Department No. 916, Organization No. 697, Object Account No. 4222, Job Order No. 091697; 2) \$37,717.00 from Department No. 19206, Organization No. 100, Object Account No. 4222, Job Order No. 019206; and 3) \$5,657.00 from Department No. 916, Organization No. 602, Object Account No. 4222, Job Order No. 916021, for the purpose of funding the above-described contracts.
