WHEREAS, there exists in the City of San Diego a need for standard housing units affordable to lower income families; and

WHEREAS, The City of San Diego has recognized this and undertaken programs to help meet this need; and

WHEREAS, federal Rental Rehabilitation funds in the amount of \$751,000 have been made available to The City of San Diego to rehabilitate rental properties in order to increase the supply of standard housing affordable to lower income families; and


WHEREAS, The San Diego Housing Commission is currently implementing the Rental Rehabilitation Program designed to rehabilitate rental units for the specified purpose and said additional funding for the program has been allocated; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Council approves submission of the Application for Rental Rehabilitation funds and designates the San Diego Housing Commission as the Agency responsible for implementation of the program, in accordance with the federal regulations and guidelines governing the program.

BE IT FURTHER RESOLVED, that the Executive Director of San Diego Housing Commission is authorized to execute the Application, Grant Agreement and any other documents necessary for funding

approval by the U.S. Department of Housing and Urban Development  
(HUD).
