RESOLUTION NUMBER R-275498

ADOPTED ON APRIL 16, 1990

WHEREAS, Charles Shuford "Shuf" Swift has been a tireless advocate for fair housing opportunities affordable to all people in balanced communities throughout the San Diego region; and

WHEREAS, Shuf Swift was a founder and director of Citizens United for Racial Equality which promoted the principals of racial equality, fair housing and balanced communities; and

WHEREAS, Shuf participated in the creation of the San Diego Unified School District desegregation plan and still monitors the progress being achieved under the magnet school, voluntary ethnic transfer and human relations programs instituted in response to the Carlin v. San Diego Board of Education lawsuit; and

WHEREAS, under his leadership as chairman of the San Diego Regional Fair Housing Task Force in 1988, a fair housing assessment was performed, the Fair Housing Council of San Diego was formed, and the Community Housing Resources Board (CHRB) was reestablished to oversee the Building Industry Association affirmative marketing agreement with the United States Department of Housing and Urban Development; and

WHEREAS, as an active member of the San Diego Housing Trust Fund Coalition, Shuf has advocated creation of a City Housing Trust Fund; and


WHEREAS, as a member of the San Diego Board of Housing Commissioners, Community Housing Resources Board, Fair Housing

Council, Urban Diversity Council, Housing Element Oversight Committee and Mayor's Neighborhood Advisory Board, Shuf Swift continues to serve the people of San Diego and work for fair and equal housing opportunities for all San Diegans; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that in recognition of Shuf Swift's lifetime commitment to equality and justice, this Council, for and on behalf of the people of San Diego, hereby declares April 20, 1990 to be "SHUFORD SWIFT DAY" in San Diego.
