WHEREAS, \$713,309 was previously authorized for expenditure by Resolution Nos. R-271848 and R-271849 dated September 12, 1988, from the Vernal Pool Preservation Fund; NOW, THEREFORE,

BE IT RESOLVED, that the transfer of not to exceed \$521,250 from the Industrial Development Fund to C.I.P. 39-108, Open Space Vernal Pool Preservation Fund, is hereby authorized to supplement the above specified \$713,309.

BE IT FURTHER RESOLVED, that the amount of \$1,234,559, including the previously authorized amount, is hereby authorized to be expended for the acquisition of the above described property and related costs, which property is more particularly described in condemnation proceedings entitled <a href="City of San Diego">City of San Diego</a> v. Brown (SDSC No. 605225).

BE IT FURTHER RESOLVED, that the provisions of Council Policy 900-3 are waived to the extent they are inconsistent with this action.
