RESOLUTION NUMBER R- 275501

ADOPTED ON APR 16 1990

WHEREAS, Highway 163 through Balboa Park is a uniquely scenic section of urban highway in California and is a park road as well as a state highway; and

WHEREAS, Highway 163 through Balboa Park is an important gateway to downtown San Diego reflecting our City's dedication to preserving a quality environment within a vibrant urban center; and

WHEREAS, Highway 163 through Balboa Park is cherished by San Diegans as a distinctive and beautiful asset to our City whose aesthetic qualities have been threatened by pressures to expand the highway's capacity; and

WHEREAS, the California Scenic Highway Program was established to protect and enhance California's beauty, amenity and quality of life while addressing transportation demands; and

WHEREAS, California cities may apply to the California Department of Transportation to obtain scenic highway designations for significant highways within their boundaries; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, for and on behalf of the people of San Diego, hereby declares State Highway 163 through Balboa Park to be a unique highway of significant aesthetic and environmental value worthy of designation and protection as a "Scenic Highway."

BE IT FURTHER RESOLVED, that the City Manger and Planning Director are hereby directed to take all necessary steps to secure "Scenic Highway" designation for State Highway 163 through Balboa Park under the provisions of the California Scenic Highway Program.
