ADOPTED ON April 17, 1990

WHEREAS, the City of San Diego and the University of San Diego Law School entered into an agreement to develop a dispute resolution program to resolve land-use violations and study the feasibility of implementing an "Environmental Court" to hear such code enforcement cases; and

WHEREAS, this agreement also required the University of San Diego Law School to compile and analyze code enforcement case data and statistics and evaluate the City's current code enforcement policies and procedures within the Building Inspection Department, Zoning Investigations and the City Attorney's Code Enforcement Unit; and

WHEREAS, on April 17, 1990, the University's Project Team presented its preliminary report on the condition of the City's code enforcement system together with its findings and seven supplemental recommendations for action; NOW, THEREFORE,
