ADOPTED ON APR 17 1990

WHEREAS, pursuant to City Council Policy 600-36 there is a procedure for requesting exemptions from the building permit limitations in University City; and

WHEREAS, the Salk Institute and the La Jolla Cancer Research Foundation have requested exemptions under Council Policy 600-36; and

WHEREAS, the City Manager has reviewed the requested exemptions by the Salk Institute and the La Jolla Cancer Research Foundation; and

WHEREAS, the City Manager has determined in his report No. 90-163 that the Salk Institute and the La Jolla Cancer Research Foundation meet the exception criteria for waivers of Council Policy 600-36, based upon extraordinary and unique public benefit; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, as follows:


1. The City Council finds that there will be extraordinary public benefit provided by these two institutions for the citizens of San Diego and potentially for all of mankind.

2. That because of these extraordinary and unique public benefits there are special circumstances justifying an exception to Council Policy 600-36 as set forth in paragraph D of that policy.

3. That the Salk Institute for Biological Studies be allocated the equivalent of 939 average daily trips under the University City Plan.

4. That the La Jolla Cancer Research Foundation be allocated the equivalent of 400 average daily trips under the University City Plan.
