BE IT RESOLVED, by the Council of The City of San Diego that the low acceptable bid of PIERCE MANUFACTURING INC., meeting specifications, is hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of SIX (6) EACH 1500 GPM TRIPLE COMBINATION FIRE APPARATUS for a total cost of \$1,130,409.00 (hose bed covers included); terms net 30 days, plus sales tax.

BE IT FURTHER RESOLVED, that a contingency cost not to exceed \$27,919.73, or 2-1/2% of apparatus cost, be provided for changes as may be necessary during the manufacturing process.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$1,240,283.38 from Fund No. 100, Department No. 120, Object Account No. 6010, and Job Order No. 5700, is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
