RESOLUTION NUMBER R- 275533

APPROVING MAP OF MESA SHOPPING CENTER EAST  
UNIT NOS. 1 AND 2.

BE IT RESOLVED, by the Council of The City of San Diego, that said Council hereby finds that certain map surveyed by Robert G. Schoettmer, Licensed Land Surveyor, entitled "MESA SHOPPING CENTER EAST UNIT NOS. 1 AND 2 being a subdivision of a portion of the east half of the northeast quarter of section 31, and a portion of the northwest quarter of the northwest quarter of section 32, township 14 south, range 2 west, San Bernardino Meridian, according to the official plat thereof, all in the City of San Diego, County of San Diego, State of California," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Westview Parkway and a portion of Mira Mesa Boulevard, and said street and portion of a public street are hereby declared to be public street(s) and portion(s) of public street(s) and dedicated to the public use, as dedicated and shown on the map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Council hereby accepts on behalf of The City of San Diego, a municipal corporation, any and

all abutters' rights of access in and to Mira Mesa Boulevard, adjacent and contiguous to Lots 3, 8, 10, 11 and portions of 2, all as shown on this map within this subdivision.

BE IT FURTHER RESOLVED that the Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of sewer and water facilities as granted and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council and that said Council has approved said subdivision map, and that said public street and portion of a public street are accepted on behalf of the public as heretofore stated.; that those certain abutters' rights of access, together with the easements with the right of ingress and egress for the construction and maintenance of sewer and water facilities, all as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
