

RESOLUTION NO. R-275541

WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

Allen Joe Wall	Park & Rec.	\$443.34	Mr. Wall is an Equipment Tech. with Central Division. His suggestion to change the procedure for cleaning sleeves and bearing guides in sprinkler parts, is expected to result in an annual savings of \$2,955.61. This is considered to be a considerable operational improvement.
Bobbie J. Bishop	Clerks	\$ 59.00	Ms. Bishop was a clerical Assistant in the Clerks Office. Her suggestion was to limit mailing and distribution of "Notice of Adjournment" for City Council meetings to one at the beginning of each recess. This will result in a savings of \$413.36 for the first year. This is considered an operational improvement.
Susan Taylor	Property	\$ 45.00	Ms. Taylor is a Word Processing Operator for the Property Department. Her suggestion was to add Department names to the City Directory where numbers are listed by subject. Although savings are difficult to identify, this is considered to be an operational improvement.
Robert Philley	Airport	\$ 25.00	Mr. Philley is an Airport Operations Assistant at Brown Field. He suggested naming the City owned road running East-West, from Heritage Road to the Navy space tracking facility located on Brown Field. This is considered to be an operational improvement.
