BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$163,000 from CIP 35-073.0 Earl and Birdie Taylor Branch Library - (Pacific Beach), is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
