BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the City Manager be and he is hereby authorized and directed to execute, for and on behalf of THE CITY OF SAN DIEGO, an Amendment to Subdivision Improvement Agreement for WESTWOOD VALLEY UNIT NO. 8, on file in the office of the City Clerk as Document No. RR-269655, to provide for the substitution of Kaufman & Broad of San Diego, a California corporation for Westwood Valley Partnership, a California general partnership, as subdivider; said Amendment to Subdivision Improvement Agreement is on file in the office of the City Clerk as Document No. RR-275598.


2. That the public improvements to be constructed pursuant to the aforementioned subdivision agreement shall be completed by November 2, 1990, as provided in the Amendment to Subdivision Improvement Agreement.

3. That Bond Nos. 2645400-NFIC and 11132748184-AIC, issued by National Fire Insurance Company of Hartford and the American Insurance Company as co-surety, in the amount of \$434,536.00 is hereby accepted as the surety for the required improvements in the subdivision, is substituted as Exhibit C to the agreement,

and Bond No. BD 391031, issued by Allied Mutual Insurance
Company, in the amount of \$1,198,718.00, is hereby released.
