

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$75,000.00 from Fund No. 100, Department 532, General Services, Buildings Division, is hereby authorized, solely and exclusively for the purpose of providing funds for this project.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer unexpended funds, if any, to the appropriate reserves upon advice of the administering department.
