RESOLUTION NUMBER R-275623

WHEREAS, The City of San Diego, a municipal corporation, is the owner of a parcel of land in The City of San Diego, County of San Diego, State of California, being a subdivision of portions of Lots 2, 5, 6, 7, and 8 of Block 4 and Lots 1, 2, 3, 4, and 5 of Block 15 of Rosedale, in the City of San Diego, County of San Diego, State of California, according to map thereof No. 826, filed in the office of the County Recorder January 21, 1897, together with North Light Avenue and a portion of Aero Drive as dedicated to public use, and together with Lemon Avenue and portions of Olive Avenue and Eighth Street as closed and vacated to public use, pursuant to the provisions of Section 66499.20 1/2 of the Subdivision Map Act, in the City of San Diego, County of San Diego, State of California; and

WHEREAS, said City proposes to file a subdivision map of said area to be known as CITY AERO DRIVE INDUSTRIAL PARK; and

WHEREAS, the Planning Commission of The City of San Diego has approved the final map of CITY AERO DRIVE INDUSTRIAL PARK and has recommended to the City Council approval of said map; and



authorized and empowered to execute, for and on behalf of The City of San Diego, the certificate of ownership on said final map of CITY AERO DRIVE INDUSTRIAL PARK, consenting to the preparation and recordation of said map.
