BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with REES-STEALY MEDICAL GROUP, INC., to provide medical treatment to the City's industrially injured and ill employees for two-year periods beginning May 1, 1990 through April 30, 1992, with an option to renew for two additional one-year periods, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 275628, together with any reasonably necessary modifications or amendments thereto which do not increase cost and which the City Manager shall deem necessary from time to time in order to carry out the purposes and intent of this agreement.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$1,500,000 from Workers' Compensation Fund No. 60029, is hereby authorized, solely and exclusively for the purpose of providing funds for the execution of the above agreement.
