RESOLUTION NUMBER R- 275629

ADOPTED ON APR 30 1990

WHEREAS, the State of California adopted the Integrated Waste Management Act of 1989 which requires the San Diego County Board of Supervisors to convene a task force to assist in preparation and implementation of an Integrated Waste Management Plan for San Diego County; and

WHEREAS, San Diego County and the majority of cities within San Diego County must approve the composition of such a task force; and

WHEREAS, after considering the suggestions of the cities, the Board of Supervisors approved a Task Force comprised of one member from the Board of Supervisors who shall chair the Task Force, one member from each of the 18 City Councils selected by each City Council respectively, and one ex-officio member who shall represent the area's military community; and

WHEREAS, the Board of Supervisors approved a weighted voting system for the Task Force which requires policy recommendations to be approved by the County representative and a majority of the city representatives representing a majority of the population; and

WHEREAS, upon approval of the Integrated Waste Management Task Force Plan the Board of Supervisors has requested approval of the composition of the Task Force, the weighted voting system and the appointment of a City of San Diego representative prior to May 1, 1990; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the Council hereby approves the composition of the Integrated Waste Management Task Force and the weighted voting formula as approved by the San Diego County Board of Supervisors.

2. That the Council hereby designates the Councilmember from District 7 as the City of San Diego's representative on the Integrated Waste Management Task Force.
