A RESOLUTION FORMALLY RECOGNIZING A COMMUNITY
PLANNING GROUP FOR THE COMMUNITY OF OTAY MESA
BY APPROVAL OF BYLAWS AND INITIAL MEMBERSHIP.

WHEREAS, it is the policy of the City Council to require each community planning committee, as a condition of official recognition by The City of San Diego, to submit a copy of its own operating procedures and responsibilities, otherwise known as "bylaws," to the offices of the City Clerk and the Planning Department; and

WHEREAS, Council Policy 600-24 requires that these bylaws must follow the format of its standard operating procedures and responsibilities and be in conformance with the criteria contained within; and

WHEREAS, Council Policy 600-24 requires that original bylaws for each community planning committee and the initial members and terms of each community planning committee shall be approved by the City Council; and


WHEREAS, a committee wishing to be recognized as the Otay Mesa Community Planning Committee has submitted bylaws and initial membership to the City Clerk and the Planning Department; and

WHEREAS, it has been determined by the Planning Department and the City Attorney (Planning Report 90-018) that these bylaws meet the requirement of Council Policy 600-24; and

WHEREAS, on February 21, 1990, the Rules and Legislative Committee voted 5-1 to approve these bylaws as recommended in Planning Report 90-018 with the provision that ONLY the beginning group membership be as recommended with a review by the Rules Committee in one year for update and possible revision; NOW THEREFORE

BE IT RESOLVED, by the Council of The City of San Diego, that the OTAY MESA COMMUNITY PLANNING GROUP be formally recognized by approval of draft bylaws, a copy of which is on file in the office of the City Clerk as Document No. RR-275634 with the provision that ONLY the beginning group membership be as recommended with a review by the Rules Committee in one year for update and possible revision.
