BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$77,857.06 (\$44,647.10 from Department No. 443, Organization No. 550, Object Account No. 6010, and Job Order No. 044355, and \$33,209.96 from Department No. 443, Organization No. 520, Object Account No. 6010 and Job Order No. 044352) is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
