

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$22,600 from Proposition A Fund 30300, Annual Allocation, Cooperative Signal Projects, CIP 68-001, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
