WHEREAS, on May 8, 1990, the Council of The City of San Diego considered the appeal of John Revels from the decision of the Planning Director in approving an early release from Single-Family Neighborhood Protection Ordinance No. 0-17250, Case No. 90-3002, submitted by Michael Palladino, Applicant, for the property located at 2252 Felspar Street; and

WHEREAS, the property is located with the Pacific Beach Community Plan area and is more specifically described as Lots 27 and 28, Block 177 of Pacific Beach Map 854, in the R-1500 zone; and

WHEREAS, the Planning Department recommended to release the subject property as the analysis of the neighborhood concluded that the area's character was multi-family; and

WHEREAS, the Pacific Beach Community Planning Committee on September 5, 1989, recommended approval for a neighborhood classification map which designates the property for multi-family development; and

WHEREAS, on March 26, 1990, after case review and public testimony, the Planning Director approved an early release request from the Single-Family Neighborhood Protection Ordinance; and

WHEREAS, subsequent to the decision of the Planning Director the City Clerk received an appeal from the case decision from an

individual alleging that no properties should be granted an early release prior to adoption of a neighborhood classification map; and

WHEREAS, this appeal was set for public hearing on May 8, 1990, and the Council having considered the matter; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the appeal is hereby granted and the early release from the Single Family Neighborhood Protection Ordinance is hereby denied.

BE IT FURTHER RESOLVED, that the decision of the Council shall be final.
