BE IT RESOLVED, by the Council of The City of San Diego that the low bid of IMPERIAL WEST CHEMICAL CO., meeting specifications, is hereby accepted and the City Manager is hereby authorized to execute a contract for furnishing LIQUID CAUSTIC SODA as may be required for a period of one (1) year beginning July 1, 1990 through June 30, 1991 at a cost of \$376.60 per ton, for a total estimated cost of \$451,920.00; terms net 30 days, plus applicable sales tax, with an option to renew for one (1) additional one (1) year period with price escalation not to exceed 20% of the bid price.

BE IT FURTHER RESOLVED, that in the event the contract vendor fails to deliver material meeting specifications, the Purchasing Agent is hereby authorized to terminate the contract and to award to the next low responsible and responsive bidder, and to successive low bidders if necessary, or to purchase liquid caustic soda on the open market until the contract can be rebid.
