RESOLUTION NUMBER R- 275691

A RESOLUTION ELECTING TO PROCEED UNDER THE PROVISIONS OF THE PUBLIC STREETS, HIGHWAYS, AND SERVICE EASEMENTS VACATION LAW, DECLARING THE INTENTION OF THE CITY COUNCIL TO VACATE THE ALLEY ADJACENT TO PARCEL 1 AND PARCEL 2 OF PARCEL MAP 15636 AND BLOCK 1 OF WILSHIRE PLACE MAP 1832, AND FIXING A TIME AND PLACE FOR HEARING THEREOF.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the public interest and convenience of said City may require the vacation of the alley adjacent to Parcel 1 and Parcel 2 of Parcel Map 15636 and Block 1 of Wilshire Place Map 1382, hereinafter mentioned.

2. That it is the intention of said Council to order the vacation of the alley adjacent to Parcel 1 and Parcel 2 of Parcel Map 15636 and Block 1 of Wilshire Place Map 1382, as more particularly shown on Drawing No. 17573-B, on file in the office of the City Clerk as Document No. RR- 275691.


3. That this Council hereby elects to proceed in making said vacation, under the provisions of the "Public Streets, Highways, and Service Easements Vacation Law."

4. The Council hereby fixes 2:00 p.m. on the 12th day of June, 1990 in the Council Chambers on the twelfth floor of the City Administration Building, Charles C. Dail Concourse, 202 "C" Street, in said City of San Diego, as the time and place for

hearing all persons interested in or objecting to the proposed vacation.

5. That The Daily Transcript, a daily newspaper published and circulated, and of general circulation, in the said City of San Diego, be, and it is hereby designated as the newspaper in which the Street Superintendent of said City shall cause to be published, in the manner and form required by law, notice of the passage of this Resolution of Intention, and the Street Superintendent is hereby directed to cause notices of the passage of this resolution to be posted in the manner and form required by law and to cause a notice similar in substance to be published in said newspaper in the manner required by law.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. The City Council, for and on behalf of the San Diego Open Space Park Facilities District No. 1, hereby declares its intention to hold a hearing to determine whether or not the District should attempt to purchase certain property, approximately 15.6 acres of Los Penasquitos Canyon Preserve - North #7, for open space park purposes.

2. That said parcel is more particularly described in that document on file in the office of the City Clerk as Document No. RR-275692.

3. That no park improvements to said property are presently proposed.

4. That on June 12, 1990, at the hour of 2:00 p.m., in the Council Chambers, City Administration Building, Charles G. Dall Concourse, 202 "C" Street, San Diego, California; the City Council will hear any persons interested in the matter of the acquisition of said property and will consider and finally act on the acquisition of said property.

5. That the owner or owners of said property may appear at the hearing and be heard orally, or by writing signed by them, and present evidence for or against the acquisition of said property by the District.

6. That a copy of this resolution shall be posted on the bulletin board of the City Administration Building and be published in a newspaper of general circulation, printed and published in the City once a week for two weeks, the posting and first publication to be on or before the 10th day prior to the day of hearing.
