WHEREAS, since 1985, The City of San Diego has become increasingly involved in locally regulating the sale of certain kinds of alcoholic beverages and advocating stricter state regulation; and


WHEREAS, the state legislature has also recently focused on regulations and taxes imposed on alcoholic beverages; and

WHEREAS, on April 4, 1990, the Rules Committee approved (4-0, Mayor not present) Intergovernmental Relations Department Report No. 90-12, dated March 28, 1990, recommending that the Council adopt policies for inclusion in the Legislative Policy Guidelines with regard to the sale of alcoholic beverages and also support proposed positions on the alcohol related bills discussed in that report; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council hereby approves the recommendations set forth in Intergovernmental Relations Department Report No. 90-12, dated March 28, 1990, regarding sale of alcoholic beverages.
