RESOLUTION NUMBER R- 275696

ADOPTED ON MAY 14 1990

WHEREAS, AB 4242 (W. Brown) would create seven regional development and infrastructure agencies in California drawn on the boundaries of an identified air basin; and

WHEREAS, in 1988 San Diego voters approved Proposition C calling for the voluntary development of a regional planning body; and

WHEREAS, this year cities within the region reviewed and supported the work of a Blue Ribbon Task Force establishing the Regional Planning and Growth Management Review Board; and


WHEREAS, the Rules Committee reviewed and approved Intergovernmental Relations Department Report No. 90-11, dated March 28, 1990, recommending that the City seek to amend AB 4242 (W. Brown) to exempt San Diego and/or acknowledge the Regional Planning and Growth Management Review Board of San Diego County; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Council hereby directs the Intergovernmental Relations Department to seek to amend AB 4242 for the reasons set forth in Intergovernmental Relations Department Report No. 90-11, dated March 28, 1990.

BE IT FURTHER RESOLVED, that the Intergovernmental Relations Department is authorized and directed to convey to the appropriate State officials the City's position in this matter.


