RESOLUTION NUMBER R- 275699

ADOPTED ON MAY 14 1990

WHEREAS, Special Olympics, through a comprehensive program of year-round sports training and organized competition, provides opportunities for children and adults with mental retardation to develop self-esteem and experience the joy of achievement through teamwork; and

WHEREAS, the Greater San Diego Special Olympics Games are held annually in San Diego to enable athletes with mental retardation to compete with fellow Special Olympians; and

WHEREAS, the Greater San Diego Special Olympics Games begins its second decade of perseverance and challenge with approximately 900 participant athletes; and

WHEREAS, the Greater San Diego Special Olympics Games draws the community into wider circles of friendship with almost 1,400 volunteers -- coaches, chaperons, family members, fellow workers, students -- helping these athletes gain confidence, physical and social skills; and

WHEREAS, the Greater San Diego Special Olympics Games to be held on June 8-10, 1990 at San Diego State University, is sponsored by the Association for Retarded Citizens-San Diego and assisted by the City of San Diego's Park and Recreation Department, Disabled Services Section; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, that this Council, for and on behalf of the people of San Diego,
