BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with HYA Consulting Engineers, for engineering services for the rehabilitation design of Climax Water Pump Station, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 275704 , together with any reasonably necessary modifications or amendments thereto which do not increase project scope or cost and which the City Manager shall deem necessary from time to time in order to carry out the purposes and intent of this project and agreement.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$44,364 from Water Revenue Fund 41502, CIP 73-263.0, Water Pump Station Restoration to Water Revenue Fund 41502, CIP 73-266.0, Climax Water Pump Station.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$81,764 from Water Revenue Fund 41502, CIP 73-266.0, Climax Pump Station, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
