WHEREAS, under the direction of City Clerk Charles G. Abdelnour, the City Clerk's office established the Legislative Information System (LEGIS) in December 1979; and

WHEREAS, the computerized LEGIS program provides for the creation of City Council dockets, and creation and storage of City Council minutes on the City's computer system; and

WHEREAS, the LEGIS program also includes fourteen other different data bases for the rapid, random access retrieval of information from the City's computer system; and

WHEREAS, the LEGIS program provides for the efficient and effective management of records and information; and

WHEREAS, the International Institute of Municipal Clerks instituted a Records Management Contest in 1990; and

WHEREAS, The City of San Diego was awarded first place in the category of Computerized/Alternative Technologies for cities of population 20,001 and over for its LEGIS program; and

WHEREAS, the International Institute of Municipal Clerks will be presenting its award to The City of San Diego on May 23, 1990 at its annual conference in Little Rock, Arkansas; NOW,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council hereby congratulates City Clerk Charles G. Abdelnour and the staff of the City Clerk's office for their outstanding

achievement in conceptualizing, developing, and implementing the
