ADOPTED ON MAY 21 1990

BE IT RESOLVED, by the Council of The City of San Diego that the low acceptable bids of 1. HYDRO-SCAPE PRODUCTS and 2. C.R. JAESCHKE, meeting specifications, are hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of TURF MOWING EQUIPMENT as follows:

1. HYDRO-SCAPE PRODUCTS for Item 1, for a total cost of \$25,755.00; terms net 30 days, plus sales tax.
2. C.R. JAESCHKE INC. for Item 2, for a total cost of \$29,400.00; terms 2% 20 days, plus sales tax.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$60,869.74 (\$27,622.24 from Department No. 443, Organization No. 830, Object Account No. 6010, and Job Order No. 001990, and \$33,247.50 from Department No. 443, Organization No. 550, Object Account No. 6010, and Job Order No. 044355) is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
