BE IT RESOLVED, by the Council of The City of San Diego that the low bid of HEWLETT-PACKARD COMPANY, meeting specifications, is hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of ONE (1) EACH GAS CHROMATOGRAPH/MASS SPECTROMETER SYSTEM for the Metro Wastewater Laboratory at a cost of \$104,532.00; terms net 30 days plus sales tax; with a warranty extension for the second year at a cost of \$6,144.00 and for the third year at a cost of \$6,384.00.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$112,110.57 from Department No. 700, Organization No. 422, Object Account No. 6010, and Job Order No. 66178, is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
