BE IT RESOLVED, by the Council of The City of San Diego, as follows:



4. That the City Clerk shall cause a certified copy of this resolution, with drawing, attested by him under seal, to be recorded in the Office of the County Recorder.

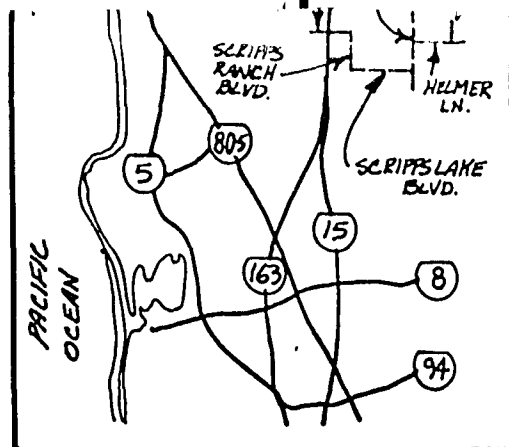

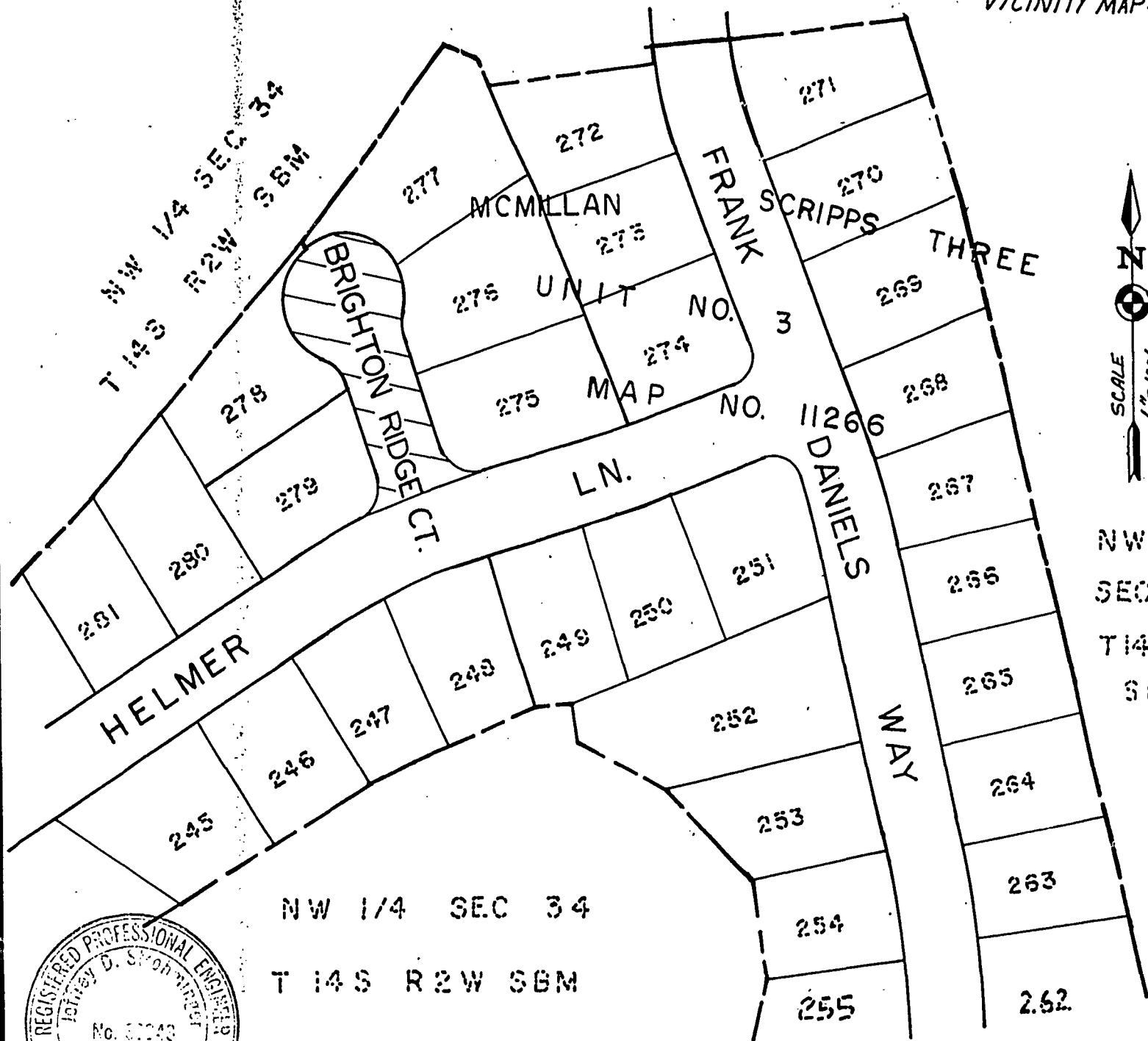

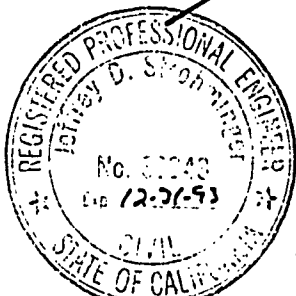
INDICATES SUBDIVISION BOUNDARY



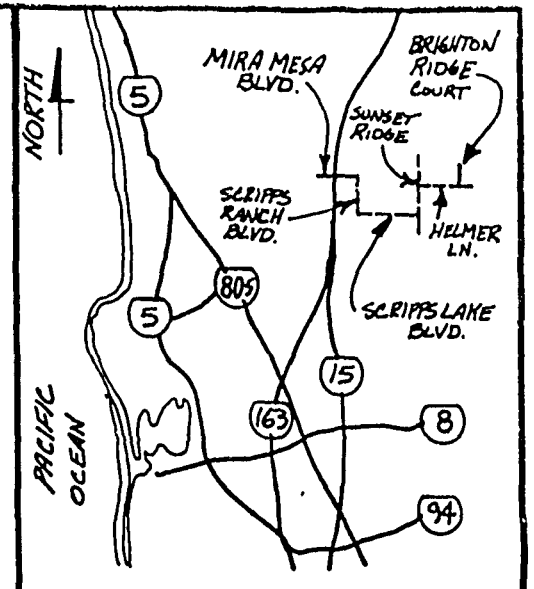

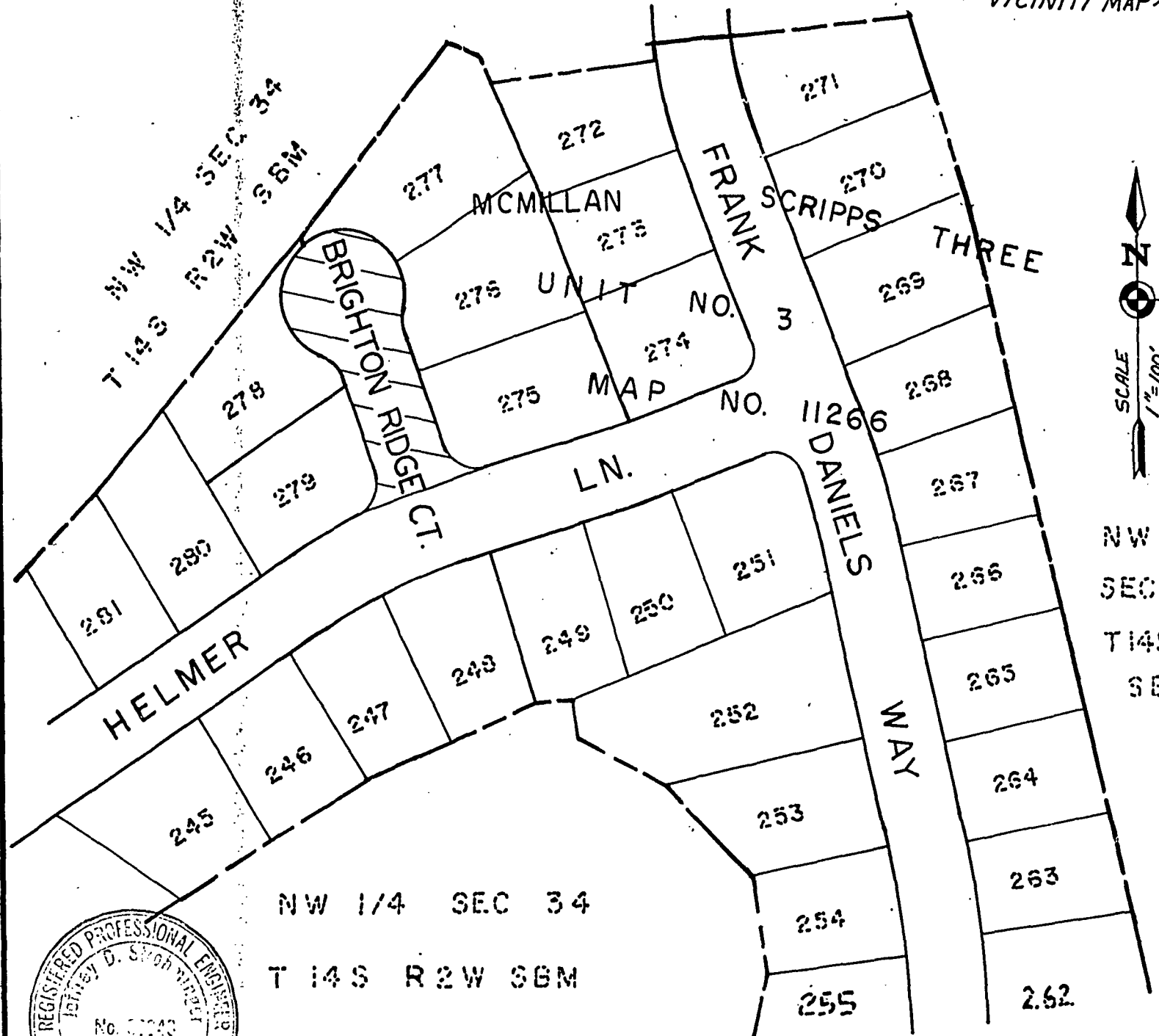
