

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with Boyle Engineering Corporation, a California corporation, to provide construction documents for "State Route 163 and Friars Road," CIP No. 52-455, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 275737.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$218,000 from Developer Impact Fees (DIF) Fund No. 79529, to CIP No. 52-455.0, "State Route 163 and Friars Road," Fund No. 79529.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$393,000 from CIP No. 52-455.0, "State Route 163 and Friars Road," Fund No. 79529, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
