RESOLUTION NUMBER R- 275742

WHEREAS, the Council of The City of San Diego finds that certain advisory boards, commissions, committees and ad hoc committees of The City of San Diego currently have conflict of interest codes and file Statements of Economic Interest (730 Forms) and some do not; and

WHEREAS, the Council has determined that it is in the public interest for all City advisory boards, commissions, committees and ad hoc committees created for a duration of one (1) year or more by statute, charter, ordinance, resolution, or other formal action of the City Council to be treated similarly by requiring each of those boards, commissions, committees and ad hoc committees to have conflict of interest codes and to file Statements of Economic Interest (730 Forms); NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego that all City advisory boards, commissions, committees and ad hoc committees created for a duration of one (1) year or more by statute, charter, ordinance, resolution, or other formal action of the Council are hereby required to adopt conflict of interest codes and file Statements of Economic Interest (730 Forms) with disclosure categories appropriately tailored to reflect the charge of the particular board, commission, committee, or ad hoc committee.

BE IT FURTHER RESOLVED, by the Council that the conflict of interest code adopted by each board, commission, committee and ad hoc committee shall be approved by resolution of the Council.
