

RESOLUTION NUMBER R-275752

ADOPTED ON MAY 21, 1990

WHEREAS, Item S407 on the Council docket of May 14, 1990, concerned the matter of Water Conservation in San Diego; and

WHEREAS, the matter was thoroughly discussed by Council and several concepts were suggested by the Mayor and Councilmembers Roberts and Bernhardt, and the City Manager; and

WHEREAS, the Council continued the matter of instituting a program of water conservation for one week to May 21, 1990; and

WHEREAS, the Council heard and discussed said matter and it was decided by Council to adopt a policy in respect to the program; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that The City of San Diego, by and through the City Manager, promptly implement a voluntary water conservation program with a goal of reducing water use by at least 10% in San Diego.

BE IT FURTHER RESOLVED, that the Mayor work with the news media to promote a strong water conservation education program to show citizens how they can best participate.

BE IT FURTHER RESOLVED, that the Mayor work with large water users, including the government of The City of San Diego, to develop innovative ways to conserve water voluntarily.

BE IT FURTHER RESOLVED, that the City Manager is directed to report back in sixty (60) days on the success of the voluntary water conservation efforts and should the program not be


successful then adoption of a mandatory water conservation program shall be considered and, further, in such event, that an ordinance enacting such mandatory conservation program be placed on the Council docket in sixty (60) days.

BE IT FURTHER RESOLVED, that the City Manager be directed to report weekly to the Council on the program's progress and come back with educational components and programs in furtherance of the water conservation efforts.

BE IT FURTHER RESOLVED, that the programming suggestions offered by Councilmember Bernhardt in her May 18, 1990 memorandum to the Mayor and Council, entitled "Water Conservation," be and the same are hereby approved and fully incorporated herein by this reference.
