WHEREAS, the Pacific Rim Interface Membership Enterprises, Inc. (PRIME) has dedicated its efforts to further education of the San Diego community through a scholarship program involving world trade; and

WHEREAS, in an extraordinary outreach effort to San Diegans, PRIME sponsors luncheons where PRIME companies can meet San Diegans who can help them with business issues and also conducts a yearly scholarship program; and

WHEREAS, PRIME's program, entitled "PRIME Educational Mission Scholarship Program" is limited to teachers in the San Diego School District and was originally designed to accommodate one person per year on all expense paid trip to Japan but now usually sends two teachers per year; and

WHEREAS, working with San Diego City Schools, PRIME searches for quality responses to its essay questionnaire by spending months reading those essays and then inviting local business persons to judge the essays; and

WHEREAS, the entire project was conceived by PRIME's president, Ichiro Wachi and represents an excellent outreach to the San Diego community, exemplifying the spirit and contribution which small businesses make to San Diego; NOW, THEREFORE,
