RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO, CALIFORNIA, ORDERING CHANGES AND MODIFICATIONS IN ASSESSMENTS IN A SPECIAL ASSESSMENT DISTRICT.

of the Assessment District and the assessment roll and Engineer's

"Report," as modified, shall now stand as the "Report" for all

subsequent proceedings relating to this Assessment District.

4. That the executed Consent and Waiver, as submitted by the

property owner, is hereby received and the original shall be kept

on file in the offices of the City Clerk.

5. That the above changes are authorized pursuant to the

provisions of Section 10352 of the Streets and Highways Code of

the State of California, and no further public hearing or other

actions are required.
