RESOLUTION NUMBER R- 275772

ADOPTED ON MAY 29 1990

RESOLUTION REQUESTING A GRANT IN THE AMOUNT OF \$277,000 FROM THE DEPARTMENT OF BOATING & WATERWAYS FOR THE IMPROVEMENT OF THE BOAT LAUNCHING FACILITIES AT SANTA CLARA POINT.

WHEREAS, The City of San Diego is desirous of improving the boat launching facility at Santa Clara Point to meet the needs of boaters and to provide public access to the water; and

WHEREAS, the California Department of Boating and Waterways is authorized to provide grants to cities, counties, districts and other public agencies for the construction and development of small craft launching facilities; and

WHEREAS, The City of San Diego has conducted an inventory of existing boat launching facilities in the area and has determined that the proposed facility at Santa Clara Point will not be detrimental to the operations of private boating businesses in the area; and

WHEREAS, The City of San Diego is willing to enter into an agreement to provide for the operation and maintenance of the proposed facility at no cost to the State; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:


1. That the Council hereby requests the Department of Boating and Waterways to provide a grant for the purpose of improving a boat launching facility at Santa Clara Point;

2. That the City agrees to accept the grant and authorizes the City Manager or his representative to coordinate, process and execute all contracts, agreements, amendments and ancillary documents necessary for completion of this project;

3. That the City Auditor and Comptroller is authorized to establish a fund in connection with this project which will earn its own interest.
