BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with Kercheval Engineers for professional services in connection with the design of the East Linda Vista trunk sewer, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 275776, together with any reasonably necessary modifications or amendments thereto which do not increase project scope or cost and which the City Manager shall deem necessary from time to time in order to carry out the purposes and intent of this project and agreement.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$257,167.00 from Sewer Revenue Fund No 41506, CIP No. 46-162.0, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.

BE IT FURTHER RESOLVED, that the City Manager is authorized to finance or refinance this agreement with tax-exempt securities if circumstances warrant.
