RESOLUTION NUMBER R- 275781

ADOPTED ON MAY 29 1990

WHEREAS, citizens and developers testified before the Transportation and Land Use Committee on November 13, 1990 about the need for a traffic signal at the intersection of Buenos Avenue and Morena Boulevard; and

WHEREAS, it was agreed that there is a need for a traffic signal at that intersection; and


WHEREAS, it was decided that it was most appropriate to establish a trust fund, entitled "Buenos and Morena Traffic Signal Trust Fund" to hold monies for the specific purposes of the installation of a traffic signal at said intersection; and

WHEREAS, funds from various sources will be deposited into this fund and all interest generated from these monies shall remain in this trust fund; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that a special trust fund, entitled "Buenos and Morena Traffic Signal Trust Fund" shall be established, for the purpose of acting as a repository of funds, to be used solely and exclusively for installing a traffic signal at the intersection of Buenos Avenue and Morena Boulevard.
