
ADOPTED ON MAY 29 1990

BE IT RESOLVED, by the Council of The City of San Diego that the low bids of 1. BUTLER PAPER AND 2. NOLAND PAPER COMPANY, meeting specifications, are hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of BOND XEROGRAPHIC HIGH SPEED COPY PAPER as may be required for the period of six (6) months beginning June 1, 1990 through November 30, 1990, per prices on file in the Purchasing Department for a total estimated cost of \$99,813, as follows:

1. BUTLER PAPER for Section I, virgin paper; terms 2% 30 days, plus sales tax, with an option to renew contract for one (1) additional six (6) month period, with price increase not to exceed 6% of original prices.
2. NOLAND PAPER COMPANY for Section II, recycled paper; terms 2% 30 days, plus sales tax, with an option to renew contract for one (1) additional six (6) month period, with price increase not to exceed 4% of original prices.
