BE IT RESOLVED, by the Council of The City of San Diego that the low acceptable bids of 1. CHEVRON U.S.A. INC. and 2. PADRE PETRO PRODUCTS - MOBIL OIL DISTRIBUTOR, meeting specifications, are hereby accepted and the City Manager is hereby authorized to execute a contract for furnishing LUBRICATING OILS AND GREASES as may be required for a period of one (1) year beginning June 16, 1990 through June 15, 1991 as follows:

1. CHEVRON U.S.A. INC. for Section I - Lube Oils and Greases Delivered in Carload Lots, and Section II - Lube Oil Delivered in Bulk to the Police Dept., for a total estimated cost of \$79,778.91; terms net, plus sales tax, with options to renew for four (4) additional one (1) year periods at a cost not to exceed 5% of prices in effect at the end of prior periods.
2. PADRE PETRO PRODUCTS - MOBIL OIL DISTRIBUTOR for Section III - Lube Oil Delivered in Bulk to Point Loma, for a total estimated cost of \$44,590.00; terms 1% 10 days, plus sales tax, with options to renew for four (4) additional one (1) year periods at a cost not to exceed 20% of prices in effect at the end of prior periods.
